## The Schupler Chronicles

#### Issue #9 - March 2025



Since it's March it's time to think GREEN. Nooo...not shamrocks or leprechauns. This month's TOSHS topic is S&H Green Stamps. Do you know what the S&H stands for (and don't Google it!)? I'll give you the answer at the end of this article.

For those of you reading this who are from a younger generation, S&H Green Stamps were given to the retail shopper upon checkout at the cash register. They were distributed at participating stores and gas stations. The number of stamps you were given depended on how much you spent.



The shopper then went home and licked the backs of the stamps and stuck them in the S&H Savings Book. Each book had 24 pages and the filled book was worth 1200 points. Then you would peruse the Rewards Catalog. The catalogs had hundreds of items in them from housewares, small appliances, and health and beauty items such as hair dryers (the kind with a hose and a plastic hood to put over your wet hair wrapped around the large pink plastic rollers using Dippity Do. Remember?). Each item in the book had an assigned number of filled books that it took to obtain the item. When you saved the required number of books for the item(s) you chose, you would rubber band them together and take them to the local redemption center to pick up your merchandise.

Interesting fact: During the 1960's S&H issued more stamps than the US Postal Service and gave out more than 35 million Rewards Catalogs a year.

I remember that my family would sit down at the kitchen table and lick the stamps. Our tongues would get pasty after licking a few dozen. If we had a lot to do, we filled a bowl with water and moistened the backs of the stamps with a wet sponge then secured them into place in the books. You had to wait until they dried before closing the book because if the book was closed when the stamps were still moist, the pages would stick together and the books could not be redeemed for full value unless the pages could be counted individually. One item that was redeemed with our stacks of books was a set of four 'leatherette' foot stools with a floral design embossed on the top. The legs were mid-century tapered with a gold band on the bottom. The colors were a mustard yellow, brick red, ecru, and avocado (picture Brady Bunch refrigerator). Mom had them lined up against the wall in the living room next to the couch. They were used often and were quite sturdy but when you have three kids, a mom, a dad, and an aunt in your home something is bound to break... and it did. The ecru foot stool lost a leg so Mom put it away in a closet because you never know when you'll need a three-legged foot stool. I discovered it decades later and smiled.

In 1972 S&H Green Stamps was sold and after several more sales, the new owner changed the name of the program to GreenPoints then it was sold again. The new company stated that the GreenPoint stamps no longer had a value and could not be redeemed, however the Greenpoint value itself could be transferred to their new redemption program called Freshpoints. It was sold in 2013 to Prologics Redemption Solutions, a company which creates private label retail rewards systems.

The value of those S&H (**Sperry and Hutchinson**) Green Stamps may not be worth anything today, but the trip down memory lane will always be worth something.

- All cats, dogs, and ferrets three months or older must be vaccinated, even if they stay indoors.
- Every dog and cat needs two rabies vaccinations, one year apart, then once every three years.
- Bring proof of the pet's vaccination history to receive a three year certificate.
- Ferrets must be vaccinated every year.
- Dogs should be on a leash. Cats and ferrets should be in a carrier or pillowcase.
- No vet exams will be given.
- Owners are responsible for cleaning up after their animals. Supplies are provided.
- A \$5.00 donation per pet is suggested to defray costs.


## **New Town Assessor**

#### Town Board Meeting - February 12, 2025

#### **Council Members Present:**

Supervisor Ronald Beach, Councilwoman Bette Szesny, Councilmen Rodney Dodge, Joe Juliano, and Eric Kane.

#### **Also Present Were:**

The meeting was called to order by Supervisor Beach and led in the Pledge of Allegiance.

#### Minutes of January 8 and January 22, 2025:

Motion by Juliano, second by Kane that the minutes of January 8 and 22, 2025 be approved as printed; all in favor.

#### **Pay Bills:**

Motion by Dodge, second by Szesny that the bills for the past month be paid as presented; all in favor.

Councilman Joe Juliano said he has arranged a meeting with Kathy Kupiec regarding the Excellus Insurance Policy. He said we are paying way too much compared to what we were paying.

#### **Highway Report by Philip Johnson:**

Superintendent of Highways Phil Johnson said we are using a lot of fuel. He said they have been plowing a lot of snow. He also urged people not to be plowing snow across roads.

#### **Assessor Report by George Haskell:**

Assessor George Haskell said people are coming in for the Star Program.

#### **Codes Enforcement Officer Philip Green:**

Codes Enforcement Officer Phil Green said it has been quiet.

#### **C2AE** West Schuyler Water Report by Barry Viggiano:

Barry Viggiano said the agencies are taking their time regarding this water project. Councilman Joe Juliano said we were supposed to put this out to bid in January, and here it is February and we are still waiting. Mr. Viggiano said we are doing our best, he said NYDFS and the DOH and others are the holdup. Mr. Viggiano said he will contact the Town one way or another by the end of the week with his results.

#### **DVR** for Court Cameras

Supervisor Beach said a new DVR is needed for the court cameras. He said he has a quote for \$250.00 to replace it and the cameras will be fixed.

#### Appointment of Dale Dodge as Budget Officer

Motion by Szesny, second by Juliano to appoint Dale Dodge as Budget Officer for the Town of Schuyler at a rate of \$5,407.50 per year; all in favor.

#### Set Public Hearing for Westgate Development

Supervisor Beach said we will set that hearing for March 12, 2025 at 5:30 P.M. and the Town Board Meeting will follow after that.

There was a discussion by Anthony Klimek regarding the fire hydrants at Westgate Development. John Scholl will look into the matter regarding the connection on the fire hydrants.

#### Direct Deposit of Employee Checks

Supervisor Beach said we will offer Direct Deposit to all employees.

#### Phone System

Supervisor Beach said he received an e-mail that Northland will run fiber optics for a new phone system at no charge.

#### Government Change to Website June 19, 2025

Supervisor Beach said due to a memorandum from the New York State Committee on Open Government, beginning on June 19, 2025 all municipalities must maintain an official website utilizing a .gov domain. Clerk to Supervisor Jeff Dingman said he is working toward that goal for both the website and town e-mails.

#### Change Town Newspaper to Daily Sentinel

Supervisor Beach said the official newspaper will now be the Daily Sentinel for the Town of Schuyler.

#### Store Opening in Approximately Two Weeks

Supervisor Beach said the ADK store in the business park will be open in approximately two weeks.

#### Water Board Report by Dale Dodge

Mr. Dodge said nothing at the moment.

## Rabies Vaccination Requirements



LICENSE ME

No dog license may expire after the expiration date of the dog's rabies vaccination. If your dog is due for a rabies vaccination booster during the next year, you must have it boostered now in order to have a full year license. If you choose not to have your dog vaccinated now, you will still need to pay the full annual fee and you will need to renew your dog license again after it has been vaccinated. Residents need to report any changes in status of ownership (i.e. deceased, moved, transferred ownership, lost or stolen).

## Dog Licensing Requirements

All dogs 4 months of age or older <u>must be licensed</u>. Dog Enumerations (Census) are performed throughout the Town periodically, and <u>all owners of unlicensed dogs are subject to new fines and penalties</u>, as set forth in the Town's Local Laws (see below):

\$7 PER DOG — SPAYED / NEUTERED w \$16 PER DOG — UNSPAYED / UN-NEUTERED

#### PUREBRED DOG LICENSE FEES



- UP TO 10 DOGS \$50.00 PLUS \$4.00 PER DOG FOR NYS DOG POPULATION CONTROL
- 11 25 DOGS \$60.00 PLUS \$4.00 PER DOG FOR NYS DOG POPULATION CONTROL
- 25 OR MORE \$125.00 PLUS \$4.00 PER DOG FOR NYS DOG POPULATION CONTROL
