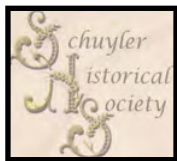

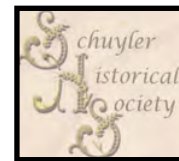

### The Schuyler Chronicles Issue 3 - August 2024

*This month the Schuyler Historical Society is excited to tell you about two beautiful items in our exhibit room. Homes long ago were decorated with items that seem unusual by today's tastes. Two such items are a beautifully framed human hair wreath (donated by Bette Jo Caldwell) and a white feather wreath (donated by Betty Robbins Currier).*

*Hair art has its roots in the 17<sup>th</sup> and 18<sup>th</sup> centuries when mortality rates were high. The keeping and saving of hair for use in jewelry or other crafts (such as wreaths) was common. However, it wasn't until the Victorian era (1837-1901), Queen Victoria wore a hair necklace of her husband, Prince Consort Albert, when he passed which sparked interest in hair art. Hair art also gained interest again with the Civil War. It became customary to make art from hair as a memorial for the deceased. In addition to remembrance of the dead, such art was also made from hair of the living as tokens of friendship.*

*Many wreaths were placed in the frame in a "U" shape symbolizing the dead's ascent upward to heaven. Closed circle wreaths were also popular as they represented everlasting life. When hair was crafted into art form, it usually took the shapes of flowers which were added to the wreaths. Beads, buttons, seashells, dried flowers, and seeds were also often included in the wreaths as adornments. When finished, wreaths would be mounted on silk or velvet backgrounds in shadow box frames which were then hung in the family home in remembrance and then passed down through the generations becoming a sort of family tree.*

*By the time World War I came around, hair art lost its popularity. People were more involved with the world around them and more issues demanded their attention. With the popularity and availability of cameras, photographs could now remind people of their loved ones as they once were in life and they no longer needed to memorialize them with locks of their hair.*

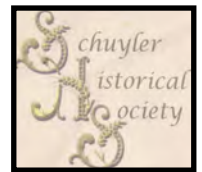
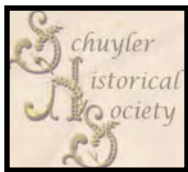

**Motion to Approve Water Tower Project:**

Motion by Dale Dodge, second by Michael Ritter that the Water Tower project at the current business park be approved by the Planning Board; all in favor.

**Application by Aldrich Trucking & Sawing, Inc.:**

Applicant Ryan Aldrich and engineer Alan Swierczek explained the project with detail. It would be a 30,000 square foot building in the current business park with office and aggregate material storage. The SWPP package is 90% done; there will be a pumping station with a 10,000 gallon tank, majority of business traffic will be early morning and late afternoon. There will be 22 trucks and approximately 30 employees. Motion by Michael Ritter, second by Dan Tripoli to adopt resolution of intent to act as lead agency and set a public hearing on the project for Wednesday, June 19, 2024 at 6:00 P.M.; all in favor.

**Highway Report by Phil Johnson:**

Superintendent of Highways Philip Johnson said Bowie and Spain Gulf S. have been paved. And the chip seal on McGraw and Wood Lane is done.

He said the salt shed has not yet been scheduled for repair and he also said the 2024 truck should arrive in September. .

Supervisor Lucenti thanked Phil Johnson for putting up the Veterans signs at Town Offices.

**Water Board Report by Bette Szesny: Not available.**

**Car Show Report by Cosmo Pellegrino:**

Cosmo Pellegrino said for the car show there is \$9,708.00 in the Extravaganza account. He said the date for the car show is August 10, 2024. He said after expenses are paid there should be approximately \$2,000.00 left for next year.

**Planning Board Report by Jeff Dingman - See Planning Board Minute(s):**

Jeff Dingman also spoke about increasing Carbonite cloud storage backup space, which would add an additional 200 GB of storage, for a total of 450 GB, for \$199.00. He also spoke about KnowBe4 security awareness training, which could be purchased for \$2,407.50 for 36 months. It was suggested to see if there was a trial period for the KnowBe4 program.

- All cats, dogs, and ferrets three months or older must be vaccinated, even if they stay indoors.
- Every dog and cat needs two rabies vaccinations, one year apart, then once every three years.
- Bring proof of the pet's vaccination history to receive a three year certificate.
- Ferrets must be vaccinated every year.
- Dogs should be on a leash. Cats and ferrets should be in a carrier or pillowcase.
- No vet exams will be given.
- Owners are responsible for cleaning up after their animals. Supplies are provided.
- \$5.00 donation per pet is suggested to defray costs.

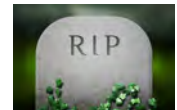
