Ian Yerdon, Senior Engineer of C2EA spoke at the February Town Board meeting to advise the Board that the West Schuyler Water Project has been sent to all involved outside agencies for review. Based on their comments, the project should be put out to bid this September.

Questions were asked by the Board regarding possible bids over the established threshold. Ian advised the Board that if the bid does come in over, we could be able to apply to our current funding agencies to offset the costs. The amount of additional funding will ultimately depend on the bid projections.

Rabies Vaccination Requirements

No dog license may expire after the expiration date of the dog's rabies vaccination. If your dog is due for a rabies vaccination booster during the next year, you must have it boosted now in order to have a full year license. If you choose not to have your dog vaccinated now, you will still need to pay the full annual fee and you will need to renew your dog license again after it has been vaccinated. Residents need to report any changes in status of ownership (i.e. deceased, moved, transferred ownership, lost or stolen).

Dog Licensing Requirements

All dogs 4 months of age or older must be licensed. Dog Enumerations (Census) are performed throughout the Town periodically, and all owners of unlicensed dogs are subject to new fines and penalties, as set forth in the Town's Local Laws (see below):

DOG LICENSE FEES

- \$7 PER DOG — SPAYED / NEUTERED w \$16 PER DOG — UNSPAYED / UN-NEUTERED

PUREBRED DOG LICENSE FEES

- UP TO 10 DOGS — \$50.00 PLUS \$4.00 PER DOG FOR NYS DOG POPULATION CONTROL
- 11 - 25 DOGS — \$60.00 PLUS \$4.00 PER DOG FOR NYS DOG POPULATION CONTROL
- 25 OR MORE — \$125.00 PLUS \$4.00 PER DOG FOR NYS DOG POPULATION CONTROL



PLEASE NOTE: In an effort to update our computer records, the town clerks' office is asking anyone who no longer owns a dog that was licensed with the town; to inform the clerk's office at 733-7458, so they can be removed from our data base. Thanks for your cooperation.

The Town of Schuyler Joins the Mohawk Valley Hometown Heroes Banner Program

This is a 3 year program. The banners have a 'life expectancy' of 5-8 years, depending on weather conditions. The banners will be given to the purchasers after 3 years. Each municipality can determine if they want to leave the banners up year round, or put them up before Memorial Day and take them down after Veterans Day. Each municipality will hang, maintain, and take down the banners.

While each municipality will need to have hardware to hang the banners, Tim Riecker of Emergency Preparedness Solutions, LLC has generously offered to pay for the hardware to hang the banners (\$70 for a single and \$120 for a double). Thank you, Tim and Emergency Preparedness Solutions!

The committee has established a website (mohawkvalleyhometownheroes.com) and has a P.O. Box where submissions can be made.

The HTH committee will accept submissions through the website and P.O. Box, organize the files and locations and submit them all for printing. The banners will be shipped directly to the Town Hall.

The cost of the banners will be \$150 for 2024. Below is an example from 2022. The banner will name each location.

Planning Board Meeting - February 7, 2024

Public Hearing – Application by Buell Fuels for Construction of an ADK Food & Fuel Convenience Store in Schuyler Business Park:

Engineer Albert Zangrilli described the project to the public in attendance. Questions from the public included concerns as to the business park/convenience store entrance, overnight truck parking, and general truck traffic and noise associated with jake brakes. Planning Board member Daniel Tripoli inquired as to a stormwater prevention plan, and was reminded by Herkimer County IDA CEO John Piseck that this information was in the packet and this project is no different than other projects which have gone into the park with regard to adhering to strict standards and guidelines.

Additional Business Related to ADK Food & Fuel Convenience Store Project:

Public Hearing for Changing the Zoning Map at Schuyler Four Corners

Questions asked as follows:

If an industrial park is being considered, there will be a lot of truck traffic which will destroy the air quality and create additional noise with idling trucks. Supervisor Lucenti said he has spoken to the Town Board and also the Herkimer County IDA and they want something nice. John Piseck said we will be very selective. He said when someone makes an offer, they will go before the Planning Board and will have to submit plans for which public hearings will be held.

Herkimer County IDA Director John Piseck said there will be no solar farms as they are not interested in an industrial park.

Another resident asked about housing development going on that land. Supervisor Lucenti and also John Piseck said there will be no housing projects and no green energy.

Another resident was concerned about property value in a residential area. Supervisor Lucenti said the only thing I can tell you is that we will be more selective than the rest of the IDA properties, as is will be considered Planned Development, which is the more restrictive. We want something nice on that property.

At this time the Public Hearing was closed.

Codes Enforcement Officer Philip Green said he is closing out reports. He said as a result of the Public Safety Meeting held on January 25, 2024 the property maintenance issue on State Route 5 is looking better.

County Legislator Report:

County Legislator Jim Bono said he wanted to thank the Town of Schuyler for their support throughout the years. Supervisor Lucenti presented him with a proclamation and thanked him for all his years of service.

Supervisor Report:

West Schuyler Water Project - Ian Yerdon

Ian Yerdon said the paperwork has been submitted to Albany, Herkimer County, and the NY State Health Department. He said paperwork has been submitted to Dave at the Mohawk Valley Water Authority and also the U.S.D.A Rural Development. He said then they will put out the project for bid. He said the tank site will be on Bell Hill Road. He said by Fall the numbers should be out and we will know if it is a go or not.

Mischael McKenna - Mohawk Valley Hometown Hero Program

Mischael McKenna said the Mohawk Valley Hometown Heroes Program is a municipality participation.

Flood Meeting Hosted by Assemblyman Smullen (January 25, 2024)

Supervisor Lucenti said that Assemblyman Smullen hosted a meeting on January 25, 2024 at the Town Office building. He said a lot of debris is in Sterling Creek and a lot of gravel, which you cannot get rid of easily due to contamination. He also said Kristen Campbell will do a BRIC grant for a fee; he said he told her to proceed.

Highway Superintendent Report by Philip Johnson:

Speed Control Signs

Supervisor Lucenti asked Philip Johnson if he knew about the accident on Windfall Road. His reply was yes, Barb told me. Supervisor Lucenti asked about speed control signs or bumpers. Phil Johnson said you cannot put up either in this type of weather. The Town Clerk said, how about a blind driveway sign? She was advised that it is a County Road and Phil Johnson said he would call Herkimer County.

Green Waste Update

There was a discussion regarding green waste pickup. Superintendent of Highways Phil Johnson said it would be costly and he does not have the manpower. It was decided to hold off for another month.

New 2024 Truck

Superintendent of Highways Philip Johnson said he will pick up the new pickup truck on Thursday and then have the plow mounted. He said on Auctions International, he will sell the 2016 Chevrolet pickup.

ZBA Meeting - Appointment of New Chairperson:

Supervisor Lucenti said Ron Beach has been appointed Herkimer County Legislator and he is no longer Deputy Supervisor. He said he would like to appoint Angela DeMichele as Chairperson of the Zoning Board of Appeals.

Resident Comment:

Tim Riecker of Emergency Preparedness Solutions, LLC indicated he would like to pay for the brackets for the Hometown Hero Program.

There being no further business to come before the Town Board, the meeting was adjourned at 7:45 P.M.

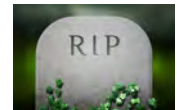
